APPLIANCE AND FLAT PANEL TV INSTALLATION WAIVER

Please read carefully

This is a release of liability and a waiver of certain rights

In consideration for Camelback Moving, Inc. ("Camelback") uninstalling appliances and installing appliances and/or flat panel TV's at my residences, I agree to the following Waiver and Release:

I understand that Camelback's representatives may not have the skill and expertise held by professional installers. I have nonetheless asked Camelback to uninstall and install appliances and/or flat panel TV's in the course of moving my property. I also do not want Camelback representatives to continue charging an hourly rate by staying after installation, even if their continued presence could minimize complications associated with the installation.

I acknowledge that uninstalling and installing appliances and/or flat panel TV's can be dangerous and can risk: (i) damage to the appliance and/or flat panel TV; (ii) damage to walls, paint, and mounting brackets; (iii) water damage to carpeting, walls, floorboards, paint, other appliances and anything else surrounding the appliance, resulting from water leaking or spraying from hoses or the appliance; (iv) damage to electrical wiring; and (v) fire damage associated with electrical wiring. **DESPITE THESE RISKS, I VOLUNTARILY CHOOSE TO HAVE CAMELBACK MOVING UNINSTALL AND INSTALL MY APPLIANCES AND/OR FLAT PANEL TV'S AND ASSUME ANY AND ALL RISKS ASSOCIATED WITH THE UNINSTALLATION AND INSTALLATION.**

I understand that if I choose to uninstall and/or install the flat panel TV's myself, Camelback Moving will not be responsible for any damage, either internal or external, caused by the TV not being placed in an upright position.

I, for myself, my heirs, successors, executors and subrogates, hereby **KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS CAMELBACK**, its directors, officers, agents, employees and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with the uninstalling and/or installing appliances, including, but not limited to, **NEGLIGENCE** of any kind or nature, whether foreseen or unforeseen, regardless of its cause, including if caused by Camelback, its agents, employees, directors, officers or volunteers or from some other cause, such as faulty wiring or poor appliance design. I, for myself, my heirs, my successors, executors and subrogates, further agree not to sue Camelback as a result of any injury caused by the uninstallation and/or installation of the appliances and/or flat panel TV's.

I HAVE CAREFULLY READ, CLEARLY UNDERSTAND, AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE AGREEMENT.
